A set of values serve a number of purposes for delivering police services:

Set forth the department's philosophy of delivering law enforcement services

State in clear terms what the department believes in

Articulate in broad terms the overall goals of the department

Reflect the community's expectations of the department

Serve as a basis for developing policies and procedures

Serve as the parameter for organizational flexibility

Provide a basis for operational strategies

Provide a framework for officers performance

Serve as a framework from which the department can be evaluated
